THRIVENT FINANCIAL

Trinity's members of Thrivent Financial continued to raise funds for the Flooring Fund and giving support to many local charities. This past year our Chicken and Biscuit Dinners supported The Julie Boots Family and the Social Hall Flooring Fund. Soup sales and "Lunch-to -Go" sales were held to increase the Flooring Fund account as well. Many members have also directed their Choice Dollars to Trinity, which also goes into the flooring fund. Choice Dollars bring approximately \$1,200 per year to Trinity. With matching funds no longer available, members have been utilizing the Thrivent Action Team system to help local causes. Each member can get two \$250 Action Cards (credit card) to buy supplies to complete a project. Unfortunately, not all members used their monies last year, so our goal this year is to use all funds available to us. We have the potential of doing \$20,000 of outreach if all members participate. ORGAN, "DIANE" UPDATE

On Sunday, April 6, 2014, our congregation voted to purchase a new Allen Digital Electronic Organ. The vote to purchase the organ was as follows: 70 – Yes, 1- No, 2-Abstain. The cost of the organ was \$75,000. It was purchased from Gerrero – Kirk Classic Organs and Pianos, 1039 Main Street, Wheeling, West Virginia, Jeff Kirk, Vice President.

At our Congregational Meeting on April 6th, we also voted on whether or not to sell the organ console, organ pipes (Not the decorative ones that are in the front of the church!) and allow church council to look into various financing options for the Organ. The down payment for the organ was paid from money that was in the organ fund, \$4,480 and \$14,270 from the Ethel Graff bequest fund. (We needed 1/4 of the cost of the organ to order it.). **The vote on the items was as follows:**

Selling of Organ Console: 68 – Yes, 2 – No, 3 – Abstain.

Selling of Old Organ Pipes 65 - Yes, 4 - No, 4 - Abstain.

Allowing Church Council to pursue the most feasible option for financing the balance of the Allen Organ Purchase: 70 - Yes, 0 - No, 2 - Abstain.

On October 1, 2014, Trinity Lutheran Church secured a \$50,000, 5 year loan from ESB Bank.

On Sunday, October 5, 2015, the same day of the Diane Bish evening concert, we dedicated our new organ to the glory of God, and our music director, David Spielvogel named our organ "Diane".

Over a period of two years many people gave generously to the Organ Fund. With money that was given by the Bill King Family and money that came in "*In Loving Memory*" of June King and Rose Bartley our new organ was paid off on August 10, 2016.

On Sunday, September 18, 2016, during our 10:30 worship service we celebrated the pay-off of the organ and burnt our debt. A special organ concert was held that afternoon at 3:00 as various organists provided celebratory music for this milestone. Thanks be to God! Well done Trinity Lutheran Church!

Pastor Peggy Suhr-Barkley's Year End Report

A decade of share ministry together, 10 years! I give thanks to God; Father, Son and Holy Spirit for a call extended by this congregation to me, on October 16, 2016, a call which officially began in January of 2017. Much has happened in our 10 years together and I know I can say I am a different pastor and person because of our journey together. First and foremost, I thank each one of you for allowing me to walk with you in our faith journey together. Over these 10 years I have gotten to know some of you better than others, mainly because of walking with you in the various occasions of your lives. There has been; Births, Baptisms, First Communions, Graduations, Weddings, Birthdays, Anniversaries, Funerals and various others celebrations, as well as the day to day living out of our faith. As much as I enjoy being with all of God's people of all ages, our children & youth continue to have a special place in my heart and so do the elderly. (I'll let you define that!) 

During the past year, council has continued to act in the best interest of the church. Thanks to the Building and Grounds Team and other volunteers, our physical property is in good condition. This is partly because we are trying to be proactive instead of reactionary in the maintenance of the property. The major water leaks seemed to be solved so we can proceed with the social hall flooring project. Different exterior and interior lights have been added to help provide a safer environment as well as help lower the electric bills. Shrubs have been trimmed. The parsonage has had a facelift as well as long overdue repairs made.

Financially, we have had highs and lows this year. We paid off the organ debt in record time and were able to burn the debt papers in the early fall. As a council, we also try to look to the future of Trinity. We try to asses and meet the needs of our members. Sometimes this means trying new things and other times it means encouraging and supporting traditions. For the past couple of years, we have once again had a Children's Christmas Program; a highlight for many members. We now have a new version of a Youth Group up and running. And we even have a 55+ group that meets and plans different activities! There has also been several Bible studies throughout the year thanks to Pastor's leadership. Do we dare think that a men's group could be organized? What ideas do you have for keeping a church life vital for people? Please feel free to express your ideas to any council member.

Last year I challenged the congregation to increase member involvement at least by 10 new volunteers. I am delighted to report that the challenge was met by both adults and youngsters. It is so exciting to see members joyfully serving and become productive members of our church family; whether it be serving on a team, singing in the choir, reading scripture, serving communion, acolyting, sending cards, mowing grass or shoveling snow. Job well

Good things are happening here at Trinity. Just remember; what happens here need not stay within the walls of this building.






