- 8. If the gift is restricted, but the funds are unable to be used due to the lack of program or need, as determined by Church Council the gift will become unrestricted after 12 months. If possible, a good faith effort will be made to notify the donor, the donor's family, or the estate prior to removing the restriction. The gift may be given another designation or begin the unrestricted gifts process, as outlined in this document, to determine the use.
- 9. This Congregational Gift Policy will be presented by the Dollars & Cents Team annually and be included in the Annual Report. The next policy review date is June of 2018.

Pastor Peggy Suhr-Barkley's Year End Report

At of the end of 2019 we have journeyed together 13 years as pastor and the people of God at Trinity Lutheran Church, Ellwood City. This year, 2020, is both the Evangelical Lutheran Church in America's (ELCA) celebration of the 50th Anniversary of the Ordination of Women and my personal 35th Anniversary of Ordination, (June 22, 1985). Even on my most difficult of days, and I am thankful there are few, I give thanks to God for this call to Word & Sacrament Ministry, a call that I first felt in 8th grade in 1970, the same year that the church ordained women. As a young woman I always thought that there were women pastors out there, somewhere, but I had just never met one!

Throughout 2019, under the theme "Rooted in Christ – 125 Years – Growing Stronger!" we celebrated Trinity's 125th Anniversary and what a great year it was! Once each month we had a time of fellowship after church that will be carried into 2020. Throughout the year we ventured through all the worship hymnals there were used in the Lutheran Church during our 125 Year History: 1917 – Common Service Book, 1958 – Service Book & Hymnal, 1978 – Lutheran Book of Worship, 1995 – With One Voice and 2006 – Evangelical Lutheran Worship. The highlight of the year was our 125th Worship Celebration and Luncheon held on Pentecost Sunday, June 9, 2019. A special worship booklet and luncheon booklet were created. Our Bishop Kurt Kusserow was with us for the celebration along with Pastor Marty Young, Pastor Fred Zikeli, Pastor Janice Altenburger and Pastor Wesley Weidenhamer. (I was there too!) A special hymn "Rooted in Christ" was written for the occasion by retired pastor, Rev. William (Bill) Brewer. Our luncheon and program afterwards was at Shakespeare's Restaurant, Ellwood City, at no cost to anyone. **Bruce Thalmann** was our masters of ceremonies. Through Fund Raisers and a "125th Anniversary" line each month on our special envelope, the cost of the luncheon was paid for, along with all Anniversary costs for the year. At year's end there is \$1,893.83 left in the Anniversary Fund as seed money for our 130th Anniversary Celebration (2024) and a couple of projects that the 125th Anniversary Team still would like to accomplish, especially the framing of the certificates presented to us by Bishop Kusserow and Mayor Anthony Court. A word of thanks to our 125th Anniversary Team; Rosetta Colao – Chair, Emily McCormish - Secretary, Dave Blank, Barb Guenther, Lori Kohlmeyer, Pastor Peggy Suhr-Barkley and Bob Zikeli.

At our first Lenten Soup Supper & Mid-Week Lenten Service on Wednesday March 13th, Pastor Peter Asplin, one of the Assistants to Bishop Kusserow came to be with us and asked me if I would be open to being an External Internship Supervisor to Vicar Chris Combs & Local Interim Pastor to Good Shepherd Lutheran Church, New Castle. This was brought before our church council and it was approved. This relationship began on August 1, 2019 and will continue until July 31, 2020. This responsibility has included weekly supervisory sessions with Vicar Chris Combs, attending monthly council meetings at Good Shepherd, attending worship quarterly at Good Shepherd and being available to Vicar Chris Combs and the people of Good Shepherd when needed. Lenten Season 2020, for our Mid-Week Lenten Soup Suppers and Services, Vicar Chris and I will be sharing the homilies and Good Shepherd Lutheran Church along with St. Paul's Lutheran Church, Ellwood City will be joining us. I ask your continued prayers for our sisters and brothers at Good Shepherd as they ponder what their future will be like after Vicar Chris leaves. This opportunity has been a gift to me in so many ways and a way that I can serve and give back to the larger church.

CONGREGATION GIFT POLICY

Purpose

To give a written process to all constituents of our congregation that outlines what types of property are acceptable as gifts above and beyond pledges or plate offerings, and how decisions are made for its use.

This policy will answer 2 core questions:

- 1. How can I provide a gift to the congregation?
- 2. How will the congregation use my gift?

Elements of a Gift Policy

- 1. Gift Acceptance
 - Defines who will decide if gift is accepted
 - Defines *what* gifts will be *considered*
- 2. Gift Use
 - Defines who will decide how gifts are used
 - Outlines process and guidelines to determine how gifts are used
- 3. Ways to Make a Gift
 - Cash or check
 - Asset transfer
 - · Beneficiary designation
 - Deferred gifts

Gift Policy

- 1. When an asset is *offered* to our congregation through an estate, or from a living individual, family, or other legal entity that is above and beyond a regular pledge/plate offering, the Dollars & Cents and Growing Stewards teams will make recommendation to Church Council to determine if the gift is **accepted**.
- 2. Our congregation is willing to **consider** the following types of assets:
 - a.Cash
 - b.Securities
 - c.Publicly traded securities
 - i.Stocks
 - ii.Bonds
 - iii.Mutual funds
 - iv.Options/warrants
 - v.Other marketable securities traded on public exchanges
 - d. Non-publicly traded securities
 - i.REITS (Real Estate Investment Trusts)
 - ii.MLPs (Master Limited Partnership)
 - iii.Closely held business interests
 - 1.Partnership units
 - 2.Limited liability companies
 - 3.S-Corp shares
 - 4.C-Corp shares
 - 5. Options/warrants

As the 2019 Pastoral Acts & Statistics indicate in this Year End Report, I conducted 23 funerals of members and non-members. I always give thanks to God, especially at this time, for all our brothers and sisters in the faith who have now entered the church triumphant. Their names appear in this Year End Report. I was blessed to be a part of their earthly journey. We lost many good saints of God this past year!

In June we took on a **HUGE** Capital Improvement Project which included; repairing, cleaning and sealing our church and educational building, filling in and sealing off the "old janitor's closet" in back of the kitchen, replacing the back exterior cement work over that location, replacing basement and educational windows, removing our old gas meter and replacing it with a new one. Many hands and several contractors were involved in this project. A **HUGE** word of thanks to **Eric Sellers** for overseeing this project. A word of thanks to all of you for your continued financial support of this Capital Project. Once again Trinity has a debt to pay off.

In a very timely fashion our Mutual Ministry Committee (Steve Duran, Herb Guenther and myself) conducted exit interviews, (I was not present), interviewed potential new staff, and recommended to our church council the hiring of Cindy Rosaci as our new secretary and Erik Nielsen as our new bookkeeper. They began their work in January 2020. We continued to be blessed by the gifts that our other staff bring to us here at Trinity; Music Director – David Spielvogel, Custodian – Joyce Hart, Youth Choir Director – Barb DeCooman and our LARK helper – Michael Grazione. Please keep our staff in your prayers and always speak well of them.

As always, I like to share with you my involvement outside our faith community. I continue to be actively involved in both our local Ministerium - our interfaith group of local pastors in Ellwood City as well as our local Beaver Area Lutheran Clergy Cluster. Both groups of pastor meet monthly. I also schedule and coordinate the Friday devotionals that appear in the Ellwood City Ledger. 125 Anniversary Team

"Rooted in Christ - 125 Years Growing Stronger!"

2019 marked the 125th anniversary of Trinity Lutheran Church of Ellwood City. The committee included these members: Pastor Peggy Suhr-Barkley, David Blank, Karen Covert, Barb Guenther, Rosetta Colao, Lori Kolhmeyer-Ott, Emily McCormish, and Bob Zikeli. The committee first convened briefly on Sunday, March 10th of 2018 and had its first official meeting on Thursday, April 4th. The group met on a nearly monthly basis until the anniversary celebration held on Sunday, June 9th and on a less frequent basis thereafter. The group focused on the history collection of our church, ways to celebrate and honor this history, how to achieve the means to do so, and how to maintain this history for future generations.



The committee's goal was to maintain a year long celebration of the life and history of Trinity interspersed with monthly gatherings and fellowship, a special church service, a congregational dinner, and other activities. In order to meet this goal, some committee members were—challenged with a mission of information gathering. This was attained by scavenging throughout Trinity's "corners and closets", interviewing senior members of the congregation, sorting through historic media and graphic elements, and reaching back throughout our shared history to glean as much information as possible to fill in knowledge gaps about our church's past. Resources included old photographs and videotapes, materials in the library, prior anniversary records, newspaper clippings, the Ellwood City Historical Society, and other items. Each month, a decade of Trinity's history was highlighted in celebration by including a "journey through the years in hymnals" – a change in our liturgy utilizing older hymnals, prayers, and songs, and by gathering each first Sunday in the Augsburg room following worship to survey artifacts from each decade and enjoy fellowship and treats.

The celebration culminated on Pentecost Sunday June 9th with a special church service with Bishop Kusserow, Pastor Janice Altenburger, and Pastor Marty in attendance, an anniversary hymn composed by Pastor William Brewer – "Rooted in Christ" to the tune of "Trinity". Pastor Peggy presided and led the worship. Following worship, a luncheon was held at Shakespeare's restaurant. Special guests, honorees, and speakers included the staff and council of Trinity, former pastors and sons of the congregation, Mayor Anthony Court, as well as our favorite Martin Luther figure. Photographs were taken following worship in the front of the church including drone video footage and the event was covered by local newspaper media. One hundred and twenty-two people attended the luncheon. Attendees were provided with an anniversary booklet and bookmark token of memorabilia. Funds were raised through cookie sales, two T-shirt sales, and individual donations and the cost of the meal was covered in its entirety. Bruce Thalmann did a wonderful job emceeing the luncheon presentation. Overall, a good time was had by all.

Following the June celebration, monthly fellowship continued at Trinity. A vignette for the stained-glass windows was created and shared with the congregation. A presentation of photographs and review of our anniversary year is being prepared by Amy Blank to be shared at the 2020 annual congregational dinner. The committee will have its final meeting on January 8th. The Augsburg room will return after being our "Anniversary" room for all of 2019. The committee will discuss ways to preserve all the data gleaned from our history for posterity. We look forward to anniversary celebrations to come and remember that we will remain rooted in Christ and will continue to grow stronger. Submitted by Emily McCormish

BUILDING AND GROUNDS TEAM

The year of our 125th anniversary, we had the wisdom and knowledge of the "Vision Team", our church council and Pastor so the church could grow, thrive, and stand for another 125 years. We went to work and decided that addressing the church's above grade external water intrusion problems were top priority; and this included replacing windows, gutters and downspouts, water proofing, etc. Eleven months of research and planning went into this project - what needed to be done and how. Approximately 33 potential venders were contacted and 5 were actually contracted to do the work. The congregation voted 89% in favor of the improvements. The actual work began in July and competed in November, 2019. The only outstanding work on the building exterior is the necessary replacement of roofing on the bell towers and a 20 x 20ft. Portion of the roof on the education wing. This work has been approved and should commence in the Spring of 2020.

There were additional Building & Grounds projects in 2019 as well. 90% of the lighting in the sanctuary was replaced with energy efficient, long lasting lights. Special thanks to Tom Pletz for finding these lights for us plus Dave Blank, Bob Porter, Bryan Neghiu and Herb Guenther for removal and replacement. Thanks to Doug Slade for removal and replacement of lights in our hallways, restrooms, classrooms and Fellowship Hall. Improvements were made in the kitchen plumbing and some of the restroom plumbing as well. Thanks to Richard Lind for his diligent care of our lawn, and to Denny Barkley, George McCool, Herb Guenther, Bob Porter, and Bryan Neghiu for removing overgrown shrubbery, plus Mike Speaker and Dave Blank for snow removal. Congregational Meeting Minutes Capital Improvement Vote June 23, 2019

President Herb Guenther brought the Capital Improvement meeting to order. He started by telling the congregation about the entire proposal and broke down each of the individual/ separate proposals from Alex Restoration, Tony Flowers, Thermo Twin Windows as well as Laszlo contract for relocation of gas meter.

Eric Sellers spoke about how (approximately 11 months) involved and how tenuous this project has been involving many different contractors, much back and forth communication, how few contractors were even willing to bid for the work and the difficult task of compiling all the information. He also reviewed all the contracts for potential cost cutting measures.

Mr. Sellers and Herb took questions from our parishioners: They specifically fielded questions regarding the Alex Restoration Contract. Were all the walls going to be cleaned, repaired and protected? The answer was yes. Another question was after the 10 year warranty, what would be the cost of reapplying the water repellent/treatment? That answer was not known, but Eric would be happy to get that answer. Were there any other bids for the project? Herb replied with none that were known. Kim Hunter informed the congregation that another bid was proposed and turned in to the Church office by Mike Hunter, but no one had seen that bid.

David Blank then discussed the Tony Flowers contract and the proposed work to be done and completed by them with no questions from the congregation.

Herb Guenther discussed the Thermo Twin window contract and fielded a question around the warranty of the windows which Herb said he would get that answer, but did not know at this time. This will be a good energy/cost cutting measure for our heating and cooling bills.

David Blank then spoke about the Laszlo gas meter relocation project with only 1 question and that was: What was the cost of the gas meter? The gas meter itself is no charge but just the cost of the removal of old and relocation of new was the cost.

Shariee Thalmann discussed the financing of the capital improvement project: Which lending institutions that were involved, how much the church would finance and where those monies were coming from. How much we would be borrowing, length of the loan term and approximate amount borrowed (\$228,601) and repaid. No questions followed from the congregation.

After review by the congregation on all the proposals and questions came to a close, Mr. Guenther asked for a motion to vote on the floor. Motion granted by Debi-Breit Adams, seconded by Bruce Thalmann. A vote from the floor was then taken from all voting members present and the results of the vote were as follows: 57 votes yes, 6 votes no with 1 abstention.

A motion at that point to adjourn the meeting was made by Nancy Horton and the second was by Dave Minett.

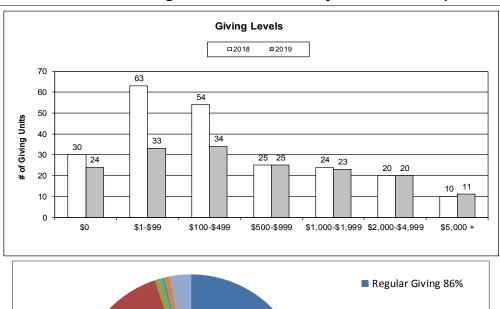

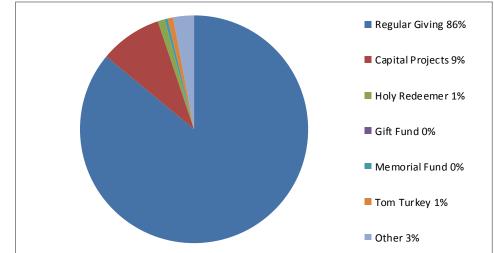

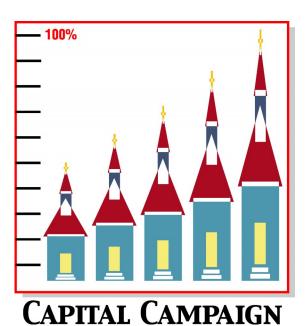
